The MSAA needs affiliates to grow!

Archery clubs and shops can affiliate with the MSAA!

The Minnesota State Archery Association was formed in 1938 and has been the leading voice for archery in the state of Minnesota. Without clubs and shops that recognize and value a voice at the state level the long historical growth of the MSAA would never have been possible. Today there are over 40 clubs and shops across the state that have stepped up and banded together to protect and promote archery by affiliating with the MSAA – would you please join them and become part of an association that has at its heart the very same things that you do?

Affiliation makes sense for your club

Affiliation is simple, affordable, and a value to your club members. The annual club affiliation fee is \$15, and once 100% affiliated your club members each get a \$5 break off regular MSAA dues. Most affiliated clubs simply add to their membership dues MSAA dues of \$15 for each head of household club member, \$5 for each additional family member, with a family maximum of \$25. The MSAA also offers an Associate affiliation level with head of household memberships being \$20, \$5 for each additional family member, and a \$30 family maximum. Your members once armed with their MSAA memberships are eligible to compete in MSAA tournaments, receive the magazine of the MSAA – *The Minnesota Arrow*, are eligible for Big Game awards, and youth scholarships. When you affiliate your club the benefits grow – you get:

- Voting power in the MSAA according to the size of your club and the level of your affiliation.
- Discounted rates on advertising in the magazine of the MSAA – *The Minnesota Arrow*.
- Your club's tournaments and events advertised free on the event calendar in the *The Minnesota Arrow* and on the MSAA website – www.mnarchery.org.
- The opportunity to bid on popular MSAA tournaments including the very successful Indoor tournament.
- The rental use of MSAA capital equipment at very reasonable rates.
- Club loans.
- The knowledge that your club with many others are enabling the MSAA to retain a lobbyist at the state capital – the Fish and Wildlife Legislative Alliance (FWLA) – that is listening and responding to matters that affect the sport of archery in the state.

Affiliation makes sense for your shop

When you affiliate your shop you are eligible to hold MSAA Indoor Tournament Regional Qualification Rounds, get the MSAA Arrow sent to you with its statewide tournament calendar, and get a discount on Manney's targets. For a shop to affiliate all that is required is the manager of the shop becomes an MSAA member and the shop pay the \$15 affiliation fee. Once affiliated the shop's name is added to the MSAA affiliate list and if you advertise in the Arrow you also get your shop logo placed on the MSAA website!

We challenge you to shop around

Archery is a wonderful and engaging activity for the whole family, and is even more so when the step is taken to reach out beyond your own community. It is no secret, there are other archery associations in the state, and the MSAA believes that each has a function and is important, but the MSAA also believes that of all it is the one that is truly essential. CLUB & PRO-SHOP AFFILIATE APPLICATION

Dear Club or Pro-shop:

AFFILIATION: The MSAA offers 3 levels of affiliation: 100%, Associate, and Pro-shop. A 100% affiliate shall have all of its members also be MSAA members. Dues collected at 100% affiliated clubs generally include MSAA dues and these clubs receive a reduced MSAA membership rate due to their 100% affiliate status. An Associate affiliate shall have at least 10 of its members also be MSAA members. If an Associate affiliate has fewer than 20 members total than at least one-half of them shall also be MSAA members down to a minimum of 5. For a Pro-shop its owner/manager must also be a current MSAA member. The MSAA Club and Pro-shop Charter application fee is \$15.00.

MSAA DUES: For 100% affiliated clubs, MSAA dues are \$15.00 for Primary membership (heads of household), plus \$5.00 for each Associate member (spouse and each child under age 18), with a family maximum of \$25.00. Clubs that are not 100% pay \$20.00 for Primary plus \$5.00 for each Associate member, with a family maximum of \$30.00. The MSAA also has a \$10.00 Junior membership category for youth age 14 and under who do not have an adult family member as an MSAA Primary member. Primary and Junior memberships include a subscription to the *Minnesota ARROW* magazine.

FORM INSTRUCTIONS: Indicate whether you are affiliating as a 100%, an Associate, or as a Pro-shop. Fill in your club or shop contact information and list the total number of current club members if you are affiliating as a club. Associate affiliates must complete the summary listing at least 10 club members who are also current MSAA members or at least one-half of their total club membership if the total club membership is less than 20. If any members listed with an Associate affiliates application are not current MSAA members attach their membership forms and dues.
